#### RENUNCIATION OF PHILIPPINE CITIZENSHIP

#### **REQUIREMENTS:**

1. Applicant must be 18 years old

### Please present the original documents and submit two (2) copies of the following:

- 2. Duly accomplished Affidavit of Renunciation of Philippine Citizenship notarized by a Notary Public
- 3. Philippine passport original will be cancelled and will be returned to the applicant
- 4. For those who have retained/re-acquired Philippine citizenship (dual citizens) under R.A. 9225, submit Oath of Allegiance, Identification Certificate and Order of Approval originals will be cancelled and retained at the Philippine Consulate General
- 5. Birth Certificate
- 6. Canadian citizenship certificate or ID / Canada passport
- 7. For those born in Canada, submit proof of Philippine citizenship of parent/s at the time of birth (e.g. Canadian citizenship certificate, permanent resident, Philippine passport)

#### NOTE:

- The Consular Officer reserves the right to require additional proof or documents from an applicant to prove his/her citizenship, status or identity pursuant to the Philippine Passport Law (RA 8239) and the Foreign Service Act (RA 7157).
- Applicants submitting by mail should provide their contact details (e.g. phone/mobile number or e-mail address) and a self-addressed registered and prepaid envelope.
- Certification fee: 33.75 CAD in cash or money order/bank draft made payable to the Philippine Consulate General. Do not send cash in the mail;
