- 1. ALL CONSULAR SERVICES THAT NEED TO BE APPLIED IN PERSON, INCLUDING THOSE FOR SENIORS, WILL BE BY APPOINTMENT ONLY.
- 2. MAKE YOUR APPOINTMENT AT THE LINKS FOUND BELOW. YOU WILL RECEIVE AN EMAIL CONFIRMATION ONCE BOOKING IS COMPLETED.
- 3. ONLY APPLICANT WILL BE ADMITTED INTO THE VENUE, EXCEPT FOR SENIORS, PWDS AND MINORS WHO MAY REQUIRE ASSISTANCE. ONLY ONE COMPANION PER APPLICANT MAY BE ALLOWED IN THIS CASE.
- 4. THERE WILL BE NO PHOTOCOPYING MACHINE AVAILABLE IN THE VENUE. ALL APPLICANTS MUST PROVIDE PHOTOCOPIES OF ALL REQUIRED DOCUMENTS.
