**BAC Resolution No. 004-2023**

**Resolution Recommending the Procurement of Services of a Licensed Electrician for the *Proudly Philippines* Food and Travel Fair event to be organized by the Philippine Consulate General in Vancouver on 03 June 2023, and the awarding of the Contract to Expert Electric with the total bid amount of Three Hundred Sixty Seven Canadian Dollars and Ninety-Four Cents (CAD\$ 367.94)**

**WHEREAS**, the DFA's Strategic Plan and its Economic Security Strategic Goals mandate the Foreign Service Posts to intensify economic promotion activities for trade, investment, tourism and services, identify or develop business opportunities for Philippine Micro, Small & Medium Enterprises (MSMEs) through promotional activities and harness overseas Filipinos in activities which promote trade, investment and tourism in the country;

**WHEREAS**, the Philippine Consulate General in Vancouver started organizing an annual Food and Travel Fair in 2019, dubbed as *Proudly Philippines*;

**WHEREAS**, the *Proudly Philippines* will highlight Filipino food and businesses, novelty items and tourist destinations through the fair and presentation of cultural performances (songs and Philippine dances) from various Filipino performers and cultural groups during the event;

**WHEREAS**, Republic Act 9184 and its Implementing Rules and Regulations (IRR), as well as the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017, prescribe the rules and procedures to be followed by agencies for goods and services to be procured and performed abroad;

**WHEREAS**, in accordance with Section 7.2 of the IRR and Annex A(3)(a) of GPPB Resolution No. 28-2017, *Proudly Philippines* Food and Travel Fair is included in the Consulate's Annual Procurement Plan for the Fiscal Year 2023;

**WHEREAS**, the Consulate intends to hire and engage the services of a licensed electrician based in British Columbia for *Proudly Philippines*;

**WHEREAS**, pursuant to Item 3(b) of Resolution No. 28-2017, the Bids and Awards Committee (BAC) caused the posting on its website, and in a conspicuous place in the Consulate, of the Request for Quotations from licensed electricians in British Columbia who can meet the following considerations: 1) able to present his license, 2) secure City permit if required, 2) hook up the extension cords to the camlock connector at the venue that will allow participating Filipino-Canadian businesses the use of multiple electrical appliances without the risk of tripping; 4) must be at the venue to connect the extension cords at 7 AM and disconnect the same after the event at 5 PM;

**WHEREAS**, in response to the Request for Quotations, the following three (3) reputable companies provided quotations:

2	SUPERB ELECTRIC	CAD\$ 532.00 (without tax)
3	KATO ELECTRICAL INC.	CAD\$ 756.00 (without tax)

**WHEREAS**, upon evaluation of the BAC, Expert Electric submitted the lowest quotation in the amount of CAD\$ 367.94 (exclusive of taxes) and is technically, legally and financially capable to meet the requirements of the Consulate;

**NOW THEREFORE**, this Committee unanimously resolves to recommend to the Head of the Procuring Entity (HOPE) of the Consulate General of the Philippines in Vancouver, the procurement of professional services of a licensed electrician for *Proudly Philippines* Food and Travel Fair, and the Awarding of the Contract to Expert Electric with the total bid amount of Three Hundred Sixty Seven Canadian Dollars and Ninety-Four Cents (CAD\$ 367.94), exclusive of taxes and other applicable charges, subject to the above requirements.
