BAC Resolution No. 014 – 2023

RESOLUTION RECOMMENDING THE LEASE OF VEHICLE IN THE CONDUCT OF THE CONSULAR OUTREACH OF THE PHILIPPINE CONSULATE GENERAL IN YELLOWKNIFE, NORTHWEST TERRITORIES, ON 30 SEPTEMBER TO 01 OCTOBER 2023, AND THE AWARDING OF THE CONTRACT TO GASTOWN NT, WITH THE TOTAL BID AMOUNT OF THREE HUNDRED NINETY-NINE CANADIAN DOLLARS (C\$ 399.00)

WHEREAS, the Consulate General of the Philippines in Vancouver (Consulate) will be conducting a consular outreach mission in Yellowknife, Northwest Territories(NT) from 30 September to 01 October 2023, to bring various consular services to Filipinos residing in far-flung areas outside the Consulate's location;

WHEREAS, a vehicle to transport the consular team and various consular equipment, paraphernalia and documentary supplies to and from the venue is critical for mobility and timely conduct of the two-day consular outreach mission in Yellowknife, Northwest Territories;

WHEREAS, the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 provides the Guidelines for the Procurement of Goods and Services, Infrastructure Projects and Consulting Services to be Procured and Performed Abroad;

WHEREAS, in accordance with Section 7.2 of the IRR and Annex A(3)(a) of GPPB Resolution No. 28-2017, the rental of vehicle for the consular outreach mission in Yellowknife, Northwest Territories is included in the Consulate's Annual Procurement Plan for the Fiscal Year 2023;

WHEREAS, pursuant to Item 3(b) of Resolution No. 28-2017, the Bids and Awards Committee (BAC) caused the posting on its website, and a conspicuous place in the Consulate, of the Request for Quotations from establishments in Yellowknife, NT that can meet the following criteria: 1) minivan that can accommodate six (6) passengers and several pieces of luggages, 2) must include protection and coverages, 3) must include mileage and fuel refill, 4) must include Loss Damage Waiver, and 5) must include concession recovery fee;

WHEREAS, the BAC requested service providers in the preferred location in Yellowknife, NT that can meet the above criteria, and the following submitted their quotations by email:

WHEREAS, pursuant to Section 36 of the 2016 Revised IRR upon evaluation of the BAC, Gastown NT has been found to be responsive to the bidding requirements and is technically, legally and financially capable to meet the requirements of the Consulate in terms of the specifications of the vehicle for the consular outreach;

NOW THEREFORE, in view of the foregoing, this Committee unanimously resolves, as it is hereby resolved, to recommend to the Head of the Procuring Entity (HOPE) of the Consulate General of the Philippines in Vancouver, the lease of vehicle for the conduct of the consular outreach mission in Yellowknife, Northwest Territories from 30 September to 01 October 2023, and the awarding of the Contract to **Gastown NT**, in Yellowknife NT, in the amount of **Three Hundred Ninety-Nine Canadian Dollars (CAD\$ 399.00)**, inclusive of taxes, subject to the above requirements and compliance by the end-user of the existing auditing rules and regulations.
