BAC Resolution No. 016 – 2023

RESOLUTION RECOMMENDING THE LEASE OF VEHICLE IN THE CONDUCT OF THE CONSULAR OUTREACH MISSION OF THE PHILIPPINE CONSULATE GENERAL ON 20-23 OCTOBER 2023 IN FORT ST JOHN, BRITISH COLUMBIA, AND THE AWARDING OF THE CONTRACT TO NATIONAL CAR RENTAL, WITH THE TOTAL BID AMOUNT OF TWO HUNDRED NINETY-FIVE CANADIAN DOLLARS AND EIGHTY-FIVE CENTS (CAD\$ 295.85)

WHEREAS, the Consulate General of the Philippines in Vancouver (Consulate) will be conducting a consular outreach mission in Fort St John, British Columbia from 20 to 23 October 2023, to bring various consular services to Filipinos residing in far-flung areas under its consular jurisdiction but outside the Consulate's location;

WHEREAS, a vehicle to transport the consular team and various consular equipment, paraphernalia and documentary supplies to and from the venue is critical for mobility and the timely conduct of the two-day consular outreach mission in Fort St John, British Columbia;

WHEREAS, the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 provides the Guidelines for the Procurement of Goods and Services, Infrastructure Projects and Consulting Services to be Procured and Performed Abroad;

WHEREAS, in accordance with Section 7.2 of the IRR and Annex A(3)(a) of GPPB Resolution No. 28-2017, the rental of vehicle for the consular outreach mission in Fort St John is included in the Consulate's Annual Procurement Plan for the Fiscal Year 2023;

WHEREAS, pursuant to Item 3(b) of Resolution No. 28-2017, the Bids and Awards Committee (BAC) caused the posting on its website, and a conspicuous place in the Consulate, of the Request for Quotations from establishments in Fort St John, BC that can meet the following criteria: 1) minivan that can accommodate six (6) passengers and several pieces of luggages, 2) must include Protection and Coverages, 3) must include mileage and fuel refill, 4) must include Loss Damage Waiver, and 5) must include Concession Recovery Fee;

WHEREAS, the BAC requested service providers in the preferred location in Fort St John, British Columbia that can meet the above criteria, and the following companies submitted their quotations:

3	Avis Rent-a-Car	Vehicle class is unavailable

WHEREAS, pursuant to Section 36 of the 2016 Revised IRR upon evaluation of the BAC, National Car Rental has been found to be responsive to the bidding requirements and is technically, legally and financially capable to meet the requirements of the Consulate in terms of the specifications of the vehicle for the consular outreach;

NOW THEREFORE, in view of the foregoing, this Committee unanimously resolves, as it is hereby resolved, to recommend to the Head of the Procuring Entity (HOPE) of the Consulate General of the Philippines in Vancouver, the lease of vehicle for the conduct of the consular outreach mission in Fort St John, British Columbia from 20 to 23 October 2023, and the awarding of the Contract to **National Car Rental**, Fort St John, British Columbia, in the amount of **Two Hundred Ninety-Five Canadian Dollars and Eighty-Five Cents (CAD\$ 295.85)**, inclusive of all taxes and other charges, subject to the above requirements and compliance by the end-user of the existing auditing rules and regulations.


