FOR OEC ISSUANCE (BALIK-MANGGGAGAWA/RETURNING WORKERS)**
for workers in British Columbia, Alberta, Saskatchewan, Yukon, and Northwest Territories

I	<p>a. Workers REGISTERED with the DMW/POEA and are returning to the SAME EMPLOYER and SAME JOBSITE</p> <p>b. Workers registered with the DMW/POEA and are RENEWING an existing employment contract</p>	<p>If you have already acquired an OEC on your initial deployment and have not changed your employer, you will be notified through your online account that you are exempted from OEC.
